
**1. ORDINANCE 2017-01 – Second Reading**

**AN ORDINANCE OF THE TOWN OF LACROSSE, FLORIDA, AMENDING THE TOWN OF LACROSSE COMPREHENSIVE PLAN, RELATING TO AN AMENDMENT TO THE TEXT AND FUTURE LAND USE PLAN MAP OF THE TOWN OF LACROSSE COMPREHENSIVE PLAN, PURSUANT TO AN APPLICATION, CPA 17-01 , BY THE TOWN COUNCIL, UNDER THE REGULAR AMENDMENT PROCEDURES ESTABLISHED IN SECTIONS 163.3161 THROUGH 163.3248, FLORIDA STATUTES; PROVIDING FOR AMENDING THE TEXT AND FUTURE LAND USE PLAN MAP OF THE COMPREHENSIVE PLAN, BASED UPON AN EVALUATION COMPLETED BY THE TOWN, AND IN RESPONSE TO THE OBJECTIONS, RECOMMENDATIONS AND COMMENTS REPORT ISSUED BY THE DEPARTMENT OF ECONOMIC OPPORTUNITY, TO REFLECT CHANGES IN STATE REQUIREMENTS PURSUANT TO SECTION 163.3191, FLORIDA STATUTES, AS AMENDED; PROVIDING SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE.**

- a. A motion was made by Councilman Gopaul to amend the agenda to select a Vice Mayor for the purpose of this public hearing and seconded by Councilman Thomas. The mayor called for a vote and the motion carried.

- c. A motion was made by Vice Mayor Thomas to read and transmit Ordinance 2017-01 Evaluation and Report Amendments to the State Land Planning Agency “DEO” and seconded by Councilman Ho. The mayor called for discussion and public comment. There was no discussion or public comment and the mayor called for a vote and the motion carried.
