Budget Report - Choi Choi

For the month of November we did fairly well overall. For the General Fund, we received \$4k of property tax earlier than anticipated. For the Street Fund, the loss was mainly due to the removal of the damaged oak tree(\$1,500) and moss treatment \$660.00). For CDBG -paid \$10k for GSG for administration, \$2,500 for relocation and \$3,500 for titles and fees. Year to date, we are doing pretty well. We have a loss in the street fund because we spent \$1750 last month to clean up after the hurricanes and \$2,100 this month for the oak tree/moss treatment.

Cash Balances:

The cash balances as of November 30,2016, October 31,2016 and this time last year were as follows.

General: 10/31/2015 \$26,922; 10/31/2016 \$35,291 and 11/30/2016 \$45,798

Fire: 10/31/2015 \$12,319; 10/3/2016 \$18,787 and 11/30/2016 \$9,781

Street: 10/31/2015 \$146,721; 10/31/2016 \$148,536 and 11/20/2016 \$147,955

CD-MM-Savings: 10/3/2015 \$146,656; 1-/31/2016 \$87,790 and 11/30/2016 \$87,808.32

I transferred \$11k back to the general fund from the fire fund. The drop in the savings account reflects our \$57,000 pull from reserves to fund the fire department roof (\$24,650) and operating deficit in the last fiscal year.

New Business:

- 1. Mr. Harold Horne from Alachua County Codes Enforcement spoke to the council about options for moving forward in our local code enforcement. There was some discussion and the council decided to wait until they had more information about the process and discuss it as the January Meeting.
- 2. Bonus The Christmas Bonus for Choi and Lee were discussed. Councilman Ewing made a motion to pay Lee \$150.00. Councilman Thomas seconded the motion,. Motion carries

Councilman Mclendon made a motion to pay Choi \$150.00 from the general fund and \$150.00 from the fire fund. Councilman Z.Gopaul seconded the motion Motion carries.

3. Sick Leave - Councilman Thomas made a motion to pay Lee 20 hours a week for 3 weeks while she is out having surgery. Councilman Mclendon seconded the motion. Motion carries.
