<u>Florida League of Cities</u>- Sharon Berrien presented Mayor Dubberly a plaque in recognition of 30 years service <u>F.D.O.T.</u> - Rebecca White, project coordinator for the F.D.O.T. Transportation Enhancement Grant reviewed the start of our resurfacing and pedestrian enhancement project. Maps showing the timing of the project were distributed.

<u>Keep Alachua Beautiful</u> - Gina Hawkins -Executive Director for the project reviewed the details for this year's project and offered supportive materials for the Town to use. Dates to be selected at March meeting.

A quorum was established at 7:17 PM when Councilman Johnny Ho arrived.

Approval of Minutes Regular Meeting January 11, 2016

For the month of January 2016 we were close to budget. The general fund did \$1,548 better than budget, which was due to property taxes being \$2,928 higher than budgeted, and timing on the audit fee payment (overall the audit fees were less than budgeted) Year to date we are very close to budget. The general fund is slightly over budget, due to the improvements in the park and the building payment, as well as timing differences on the audit. Adjusted for the **Building/equipment allowance** our budget included \$20,000 in building improvements and improvements and \$10,000 in specific equipment that was necessary by 2016 to remain compliance. These two allowances are in in the annual budget for equipment. The roof for the fire department will use \$12,325 of the remaining budget, so we really only have \$2,290 in the budget for improvements and equipment...
